1. **Call to Order.** (Welcome by Senator Barbara Favola)
2. **Approval of past minutes.** (Senator Barbara Favola)  
Nancy Fowler made a motion to accept the minutes from the last meeting on September 1, 2015. Kathy Robertson seconded the motion. The minutes were adopted by the Advisory Committee.
3. **Committee Member Introductions**
4. **Overview of VOCA Listening Sessions** (Francine C. Ecker)  
An overview of the four listening sessions conducted by DCJS was provided. The purpose of the listening sessions were to hear from advocates in the field to determine the best uses of the additional funds, to address some long standing needs in Virginia, and to continue to promote and sustain partnerships among and between victim advocacy programs and organizations as

well enhancing services to underserved populations and unmet needs in Virginia. The major themes that were identified from the listening sessions were:

- Strengthen capacity of current programs
- Outreach & Awareness
- Infrastructure Needs
- Technology
- Trauma Informed Services/Training
- Community Organizing/Collaborations
- Increase Hotline Capacity
- Legal Assistance

5. **Agency Roundtable Discussion.** Members of the Advisory Committee that represent state agencies or statewide non-profit organizations were invited to discuss their programs and detail the work currently being conducted by their agencies as they relate to domestic and sexual violence.

During the roundtable discussion, Kristi VanAudenhove expressed a need for members to advocate to Congressional Delegates to maintain the current level of VOCA funding. Senator Favola moved for the Advisory Committee to draft a letter to Congressional Leaders. Through unanimous decision, the Advisory Committee agreed to send a letter to Congressional Leaders regarding reductions and withdrawals from the Crime Victims Fund.

6. **Virginia Sexual and Domestic Violence Program Professional Standards Appointments.** Recommendations were made for Virginia Sexual and Domestic Violence Program Professional Standards Committee.
